MNRF Broad Scale Fish Monitoring

Over the years, we have been aware of the presence of the Ministry of Natural Resources (MNRF) on our lake. They are charged with the responsibility of monitoring the health of lakes in our province. One of the main indicators of the health of a lake is the health of the fish that live in the lake. In order to catch a variety of fish to test, the MNRF uses the method of gill netting. Unfortunately, it appears to many of us, that gill netting may be occurring at a cost, as the net catches a large number of fish. Last year we contacted the MNRF and discussed our concerns about using this technique to catch fish for testing. They have repeatedly assured us that the benefits of catching the fish and monitoring, far outweighs the impact on the healthy fish population. They have also stated that the number of fish caught is a very small fraction of the overall fish population.

As a result of our concerns, the MNRF has responded by scheduling Preston Lennox to attend our AGM on July 21st. Our understanding is that Mr. Lennox will share the results of last year's fish inventory and explain why they use the gill netting process to perform this inventory. If you have concerns about the fish populations in the lake, this will be an ideal opportunity to have your questions answered

AND WHAT THEY TELL US --



Water clarity has been the benchmark quality indicator for Big Basswood since BBLA began participating in the Lake Partner Program (LPP) in 1999. The annual average secchi disk readings have been consistent through the years at 10-12 meters making us one of the clearest lakes in Ontario.

Total phosphorus is a measurement used to manage and assess lake nutrient status and algae growth Phosphorus occurs naturally but also finds its way into lakes via human pathways: e.g. septic wastes, fertilizers, laundry detergents, etc. Human caused changes can impact the natural phosphorus cycle. An example of this would be recent algal blooms. Big Basswood Lake TP is, and has been, consistently low.

Calcium is an essential element that is present in natural waters. It's in limestone and other types of rocks. Calcium gets into the water through leeching of soils, weathering of rocks, effluent and other point sources. It is important to all life forms, both aquatic and terrestrial. Calcium levels are declining in Canadian Shield Lakes which are proving to be a stressor for many aquatic species. Calcium levels are essentially unchanged on Big Basswood. The range of Calcium levels reported by LPP participating lakes is approximately 2-37.

Septic Inspection Program

Big Basswood Lake Association (BBLA) has a long time commitment to maintaining the pristine water quality of Big Basswood Lake. Last year BBLA was successful in obtaining a grant from the Ontario Trillium Foundation to review onsite sewage and surface water drainage systems on our lake's shoreline properties. So THIS summer, it is happening!!!

This is an opportunity to analyze your drainage systems and learn what can be done to improve functions. Septic system maintenance, surface water management, water conservation and other best management practices can be discussed. Basically we can all learn about our systems. Trillium grant funding and a contribution from the lake association makes this available to each of us. The site visit and assessment are **FREE**, but the window of opportunity is just for the 2019 season.

Many of you have already scheduled a site visit, but if you haven't done so yet, call the Municipality of Huron Shores (705-843-2033) to schedule your appointment. Brysin Shaw, from Tulloch Engineering, will be making the property visits and if possible, it is best for the property owner to be there. Bryson will ask questions and you are encouraged to ask him questions in return.

Note that this inspection is totally non-invasive. No digging up of tanks is required as Brysin does surface inspections only.

Septic systems are out of sight and surface water drainage is only a problem when there is a water event, but anticipating problems is key to functioning systems and maintaining water quality. It falls to each of us to assure that our lake remains clear and beautiful.


Judging

2019 Loon Survey Report

Our Basswood Lake loon survey ,which is a contribution to the Canadian Bird Studies Loon Survey, continues this year. There are participants from five sections of the lake—SE, SW, NE, NW, and Big Island-Center area. This is the third summer of recording loon observations and submission results to CBS. We welcome new participants.



The survey is completed on a simple form, documenting number of observations of the lake for loons, number of pairs observed, number of chicks, and other bird species that have been observed.

Dam Operating Plan

On July 30, 2019 the MNRF held a meeting with representatives from Bright Lake and Big Basswood Lake to present information and answer questions about the Big Basswood Lake Dam Operating Plan. Shannon Hobbs, Research Management Technician from the MNRF, provided an overview of the dam operating plan, the interactions between both lakes and factors that are

considered in determining water levels.

All lakes go through cyclical water level changes. The water level changes (the highs and lows) are moderated by dam operations. The operating range at the Big Basswood Lake Dam is only 10 cm and there is little room to adjust water levels. Water from Big Basswood has been used to flush through Bright Lake during bluegreen algae break-outs (1999 and 2011) and to benefit walleye spawning. It is a balancing act. The amount of rainfall, either too little, too much or too fast, will affect water levels. The MNRF uses one month and three month forecasts from the Aviation and Forest Fire Emergency Services. A lake's watershed is also affected by weather trends. A draught results in dry wetlands, ponds and streams so little additional water reaches the lake. In flooded or saturated conditions, water is not absorbed and the run-off almost immediately flows into the lake.


The replacement of the Big Basswood Lake dam is in process although presently there is not a timeline for this project. The Dam Safety Assessment has been completed. When the dam replacement is approved the MNRF is expecting up to 3 years notice. There will be an Environmental Assessment done which will be include public comment.

This information illustrates just how complex and dynamic water is. Managing lake levels, just one aspect of water management, is dependent on numerous factors and changing conditions. Thank you to the MNRF for providing the opportunity to meet and inform lake residents about dam operating procedures.

Update – Summer 2019 ... a number of residents have contacted the lake association with a concern about how low the lake level was this July in spite of the fact that Bright Lake and the Mississagi River continue to be at very high levels after our excessive snowfall levels this winter. The MNRF has been contacted and explains that the water levels have been reduced slightly (1 inch below the wing wall at this writing) to allow for an engineering inspection of the wing wall which is scheduled in the next 2 weeks. We will continue to be in touch with the MNRF to understand the results of this inspections and next steps in the repair and/or replacement of the dam.

Thessalon First Nations Boundary Land Claim

As discussed at our 2018 AGM last year and documented in our last newsletter, the Thessalon First Nation has filed a boundary land claim with the federal and provincial governments. In this land claim, Thessalon First Nation asserts that there was a miscommunication in the drawing of the boundaries during the negotiation and signing of the Robinson Huron Treaty of 1850 and that the boundaries of the reserve should have been expressed in leagues (3 miles) instead of miles so that the total area covered in the treaty was one ninth of the area ie. The asserted area for the new boundaries encompasses Big Basswood Lake in its entirety. Note that just because this falls within the asserted area, the actual candidate lands for transfer to the First Nations will be determined during the negotiation.

The government has agreed to negotiate this claim. The negotiation is being led by Mark Richard of the Ontario Ministry of Indigenous Relations and Reconciliation (MIRR). Mark has continues to update status/progress with the Basswood Lake Association as we are important stakeholders.

We continue to be assured that no private properties or access to private properties will be impacted by the settlement.

We were in contact with Mark via email on June 19th and understand from him that the negotiations should still be characterized as in there early stages and that there is no further information to share at this time. Please look at the recent SooToday article reference below which talks about the recent Garden River ratification vote – after x years of negotiation.
