Parc Update

For the past year, the lake association, in consultation with Lincoln North, has been studying the MPAC assessments on Big Basswood Lake to determine if there was any basis for a collective appeal of assessments on behalf of all property owners. As reported in the spring newsletter and at the annual general meeting, when we compared the sales price of the last 16 property sales on the lake with their corresponding assessments, we found that, on average, the assessment accurately reflected the sales price. As a result the recommendation of the board to the membership was that there was no basis for a group appeal. If individual property owners decided that they still wished to pursue an appeal of their particular assessment, Lincoln North offered at the meeting to consult with the property owners on the process.

The association followed up with a "town hall" meeting which was held on August 4th. The intent of this

meeting was to provide a forum for individual property owners to discuss the assessment process with Lincoln and get advice on how they might proceed.

The board will continue to monitor sale prices on the lake and report at next year's AGM. At that meeting, we will assess if there is any interest in further formal activity on property assessments.



Septic System Dos and Don'ts

- *Do learn the location of your septic tank and drainfield. Keep a sketch of it handy with your maintenance record for service visits.
- *Do have your septic system inspected annually.
- *Do have your septic tank pumped out by a licensed contractor, approximately every three to five years, or as often as is appropriate for your system *Do keep your septic tank cover accessible for inspections and pumping. Install risers if necessary.
- *Do call a professional whenever you experience problems with your system, or if there are any signs of system failure.
- *Do keep a detailed record of repairs, pumping, inspections, permits issued, and other maintenance activities.
- *Do conserve water to avoid overloading the system. Be sure to repair any leaky faucets or toilets.
- *Do divert other sources of

water, like roof drains, house footing drains, and sump pumps,

away from the septic system. Excessive water keeps the soil in the drainfield from naturally cleansing the wastewater.

- *Don't go down into a septic tank. Toxic gases are produced by the natural treatment processes in septic tanks and can kill in minutes. Extreme care should be taken when inspecting a septic tank, even when just looking in.
 *Don't allow anyone to drive or park over any part of the system.
 *Don't plant anything over or near the drainfield except grass.
 Roots from nearby trees or shrubs may clog and damage the drain lines.
- *Don't dig in your drainfield or build anything over it, and don't cover the drainfield with a hard surface such as concrete or asphalt. The area over the drainfield should have only a grass cover. The grass will not only prevent erosion, but will help remove excess water.

*Don't make or allow repairs to your septic system without obtaining the required health department permit. Use professional licensed onsite contractors when needed.

- *Don't use septic tank additives.
 Under normal operating conditions, these products usually do not help and some may even be harmful to your system.
- *Don't use your toilet as a trash can or poison your septic system and the groundwater by pouring harmful chemicals and cleansers down the drain. Harsh chemicals can kill the beneficial bacteria that treat your wastewater.
- *Don't use a garbage disposal without checking with your local regulatory agency to make sure that your septic system can accommodate this additional waste.
- *Don't allow backwash from home water softeners to enter the septic system.
